

SUPER BIKE RENTAL AGREEMENT AND POLICIES, GOA

Motorbike Rental Agreement



I hereby acknowledge and agree to the following rental agreement terms and conditions:

1. **Term.** This agreement shall commence on the day the Renter takes possession of vehicle and remain in full force and effect until vehicle is returned to owner. Renter shall return the vehicle on ----/----/----- unless this agreement is terminated earlier consistent with the term herein.
 - a) Motorcycle is rented out clean and in proper working condition and must be returned in the same manner.
 - b) Helmets are required to be worn at all times while riding motorcycle rented from UN-CLUTCH Rentals. If a customer is seen riding the motorcycle without a helmet, they will immediately have to return the motorcycle without any refunds.
 - c) Unless due to the fault of the owner, all fines, penalties, traffic and/or parking violations, court cost, towing charges and other expenses relating to the vehicle assessed against owner or the vehicle during the rental Term.
 - d) Motorcycles are maintained on a daily basis. It is the responsibility of the client to check the bike at the store BEFORE setting out any ride.
 - e) A surcharge of RS. _____ under the age of 24.
 - f) A surcharge of RS. _____ for additional Rider.
 - g) A surcharge of RS. _____ for Pickup
 - h) A surcharge of RS. _____ for Drop (North Goa South Goa Panjim)

2. **Security Deposit.** In addition to the fees listed Renter shall pay a deposit of RS. _____ at the time this Agreement is signed. Owner may use the deposit to cover any amounts due under this Agreement.

Customer agrees to return the bike in clean, UNDAMAGED condition to avoid any Additional charges for repair, maintenance or replacement. Customer accepts use of the equipment, As is in good condition and accepts full responsibility for care of the equipment while under his/her possession. Damaged parts and components will be replaced at the Motorbike original company service station and customer agrees to pay regular retail prices for components replaced. Clean condition means normal wear and tear is accepted but does not include broken lights, rims, bent rims, damaged frames, handlebars, seats or other parts from misuse and/or crashes. Note: Late returns are subject to fees.

Customer agrees to provide UN-CLUTCH with credit card details, for precautionary use only: I authorize UN-CLUTCH to charge the credit card or debit card they have on file for me for all eventual costs in case of damages to the motorcycle during my rental period. In case of theft, I will be responsible for reimbursing UN-CLUTCH for the original Price of the motorcycle, plus the cost of any accessories that were provided at the time of the motorcycle rental.

ASSUMPTION OF RISK, WAIVER AND RELEASE AGREEMENT

Assumption of Risk: I understand and accept that renting this motorcycle can cause personal injury, risk of death (including but not limited to severe spinal or head injury) and loss of or damage to property. I also understand I should be in good physical health to participate in motorcycling, and I confirm that I have no significant health issues that prevent me from participating in motorcycling. In spite of the Aforementioned risks and acknowledgements. I understand the in herent risk involved in using this rental motorcycling equipment and accept full responsibility of injury or loss of life to myself or damage to property arising out of renting this motorcycle.

3. **Authorized Riders:** Only those who are a party to this Agreement, sign the agreement and have a current valid drivers license to operate the vehicle are permitted to ride the vehicle. Any other riders are prohibited from operating vehicle.

4. **Restriction on Use.** Renter shall not:

- a) Permit the vehicle to be ride by any person who is not an authorized rider under this Agreement;
- b) Operate the vehicle or permit it to be operated in violation of law, including but not limited to driving under the influence of alcohol or drugs, or in the breach of rules and regulations of road traffic.
- c) Operate the vehicle or permit it to be operated to commit a violation of law;
- d) Operate the vehicle or permit it to be operated for any race, test or contest;

5. **Repair or loss and Reporting to Police.** Vehicle shall not be serviced or repaired and parts and accessories shall not be replaced without owners prior consent. Renter shall alert owner to any damage to the vehicle. Renter shall be responsible for any loss or damage to vehicle and loss of use, diminution of the vehicles value caused by damage to it or repair vehicle or if vehicle is subject to theft or vandalism Renter shall report the accident or incident to owner as soon as possible.

6. Rider are not allowed to take vehicle on any roads, beach, driveway, or surface likely to cause damage to the vehicle.

I HAVE CAREFULLY READ THIS AGREEMENT IN ITS ENTIRITY AND UNDERSTAND ITS CONTENT. I AM AWARE THIS IS AN ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY AND SIGN IT VOLUNTARILY.
